Skin Contact: Remove contaminated shoes and clothing and cleanse affected area(s) thoroughly by washing with mild soap and water or a waterless hand cleaner. If irritation or redness develops and persists, seek medical attention.

Inhalation: First aid is not normally required. If breathing difficulties develop, move victim away from source of exposure and into fresh air in a position comfortable for breathing. Seek immediate medical attention.

Ingestion: First aid is not normally required; however, if swallowed and symptoms develop, seek medical attention.

Most important symptoms and effects, both acute and delayed: Inhalation of oil mists or vapors generated at elevated temperatures may cause respiratory irritation. ## SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures: This material may burn, but will not ignite readily. Keep all sources of ignition away from spill/release. # **SECTION 7: Handling and storage**

**Precautions for safe handling:** Keep away from flames and hot surfaces. Wash thoroughly after handling. Wear protective gloves/protective clothing/eye protection/face protection. Persistence and Degradability: Polyalphaolefins (synthesized hydrocarbons) & polyalkylene glycol synthetic base oils are not considered to be readily biodegradable but may be inherently biodegradable.
