Environmental Precautions: Stop and contain spill/release if it can be done safely. SECTION 7: Handling and storage

Precautions for safe handling: Keep away from flames and hot surfaces. Do not breathe vapor or mist. Wear protective gloves/protective clothing/eye protection/face protection. Contaminated work clothing must not be allowed out of the workplace. Wash thoroughly after handling. Use good personal hygiene practices and wear appropriate personal protective equipment (see section 8). Spills will produce very slippery surfaces. Used motor oils have been shown to cause skin cancer in mice after repeated application to the skin without washing. Brief or intermittent skin contact with used motor oil is not expected to cause harm if the oil is thoroughly removed by washing with soap and water. Do not enter confined spaces such as tanks or pits without following proper entry procedures such as ASTM D-4276 and 29CFR 1910.146. Do not wear contaminated clothing or shoes.

Conditions for safe storage: Keep container(s) tightly closed and properly labeled. Use and store this material in cool, dry, well-ventilated area away from heat and all sources of ignition. Store only in approved containers. Keep away from any incompatible material (see Section 10). Protect container(s) against physical damage.

Target Organ(s): A 28-day oral feeding study of rats by gavage was conducted with dosage levels of 50, 250 and 1,000 mg/kg/day. All animals survived. Pathological examination of organs showed microscopic changes in the liver of the mid and high dose male and female rats. These changes were characterized by enlargement of hepatocytes. Kidney changes were observed in the mid and high dose females. These changes were characterized by an increased basophilia of the cortical tubules predominantly in the distal convoluted tubules. The no effect level (NOEL) appears to be 50 mg/kg/day.

Mobility in Soil: Volatilization to air is not expected to be a significant fate process due to the low vapor pressure of this material. In water, this material will float and spread over the surface at a rate dependent upon viscosity. The main fate process is expected to be slow biodegradation of individual components in soil and sediment.
